### **COURSE SYLLABUS**

#### **BUSI 691** Healthcare Administration Capstone

#### **COURSE DESCRIPTION**

This capstone course for all healthcare administration majors seeks to integrate the concepts, techniques, and knowledge of all areas of healthcare administration. Its focus is strategic management, which is studied in theory and then rigorously applied. This course is designed for final semester seniors.

#### RATIONALE

A major component of the healthcare administration program is the capstone course that requires students to apply what they have learned throughout the curriculum. The overall objective of the capstone course is to enable students to build upon their theoretical preparation. Students, working collaboratively as they would in an organization, will enhance their leadership skills and systematic problem/issue analysis skills, etc. through direct participation in case analysis and other focused experiences.

#### IV. MEASURABLE LEARNING OUTCOMES

- B. Synthesize the knowledge gained from life experience and previous graduate Healthcare Administration curriculum.
- C. Demonstrate knowledge of the functions of marketing, accounting, financial analysis, human resource management, strategic management, and operations management, and how these individual activities work together to optimize the healthcare organization's performance through the creation of a strategic plan.
- D. Synthesize and articulate an optimal and ethical strategic plan founded upon Christian principles.
- E. Generate effective team management skills to produce team goals, strategies, and performance measures.

After reading the Course Syllabus and <u>Student Expectations</u>, the student will complete the related checklist found in Module/Week 1.

C. Discussion Board Forums (4)

Discussion boards are collaborative learning experiences, therefore the student will be assigned to a group for this course. Each group is required to provide a thread in response to the provided prompt for each forum. Each thread must be at least 600 words and demonstrate course-related knowledge. In addition to the thread, each group is required to reply to 2 other groups' threads. Each reply must be at least 200 words. Each group will discuss the prompt within the Discussion Forum, but only one group member will post the threads and replies from his/her group. Each thread and reply must include a biblical integration and at least 2 peer-reviewed source citations in current APA format in addition to the text.

D. Group Assurance of Learning Exercises (3)

The student will read each respective case from the Walston text. Each student will be assigned to a group and will collectively respond to the case questions. The group will demonstrate their ability to diagnose strategic issues, evaluate alternative solutions, and recommend actionable plans. Each group's analysis must be 3–5 pages and supported by at least 3 peer-reviewed sources cited in current APA format.

E. Peer Evaluations (3)

After each Group Assurance of Learning Exercise (3), each student will evaluate the contributions of his/her group members using the provided Peer Evaluation Form. Each student will also be evaluated by his/her fellow group members.

F. Individual Assurance of Learning Exercise

The student will read "The Struggle of a Safety Net Hospital" case in the Walston *Strategic Healthcare Management: Planning and Execution* text. The student will individually respond to the case questions in a 3–5 page paper. The student's analysis must be supported by at least 3 peer-reviewed sources cited in current APA format.

G. Competitive Market Benchmark Analysis Exercise

The student will complete this assignment in correlation with the Individual Assurance of Learning Exercise. The student will answer questions relating to his/her industry or field of study. Current APA formatting must be used.
